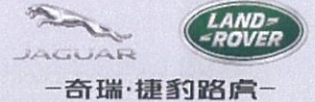


# Alert Management Warning Letter

Dear all Suppliers Partner,

Alert 作为临时授权在生产制造过程中或已经下线的车辆上使用与工程发布状态不一致的零件或工艺, 包括但不限于以下几种情况, 必须向 CJLR PD 申请并获得 alert 授权后方可执行, 请牢记:

Alert is temporarily authorized to use part or process which is not in line with engineering release status for manufacture and vehicle in parking yard. Application for an alert from CJLR PD at first time and get authorization is mandatory including but not limited to the following situations. Please keep in mind:

1. 申请使用与发布状态不同的零件装车(如: CJLR 订单与实物版本不一致, 实物和图纸不一致)。Apply to use parts that are different from release status for vehicles building (CJLR order not align with actual part, actual part not align with data etc.)
2. 申请使用当 PSW 没有被完全批准零件装车, 务必有已批准的 alert 和临时 PSW 支持。Apply to use parts when PSW is not fully approved, the interim PSW with an approved alert is mandatory.
3. 申请使用返修零件装车。Apply to use repaired parts for vehicles building
4. 其他需要工程批准的临时行动。Other temporary actions that need engineering authorization
